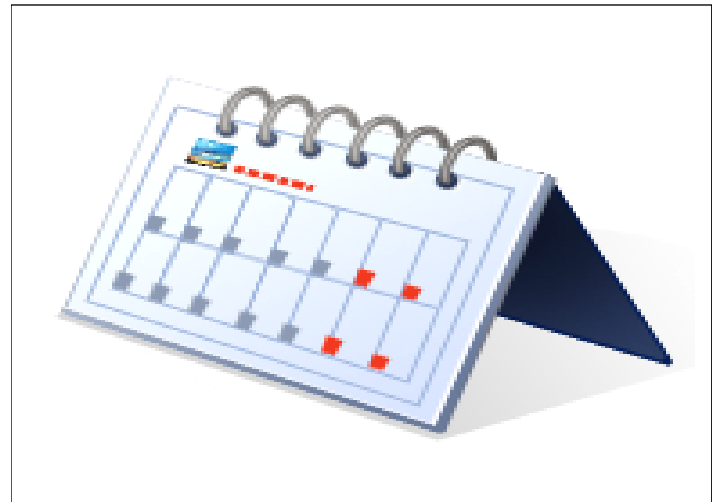
If you require child care for the February 8 Presbytery Meeting, you need to contact Ann Marie in the Presbytery office by the 31st.
