15. How are you fulfilling the requirement in G-11.0403c? *(The ministry shall give evidence of theologically informed fidelity to God's Word. This will normally require the Master of Divinity degree or its equivalent and the completion of the requirements for ordination set forth in G-14.0402.)*
16. How are you fulfilling the requirement in G-11.0403d? *(The ministry shall be carried on in accountability for its character and conduct to the presbytery and to organizations, agencies, and institutions.)*

17. How are you fulfilling the requirement in G-11.0403e? *(The ministry shall include responsible participation in the deliberations and work of the presbytery and in the worship and service of a congregation.)*
