The Presbytery of Tampa Bay will gather for a Stated Meeting on Saturday, May 4, 2019 at Northwood Presbyterian Church, 2875 State Road 580, Clearwater, FL 33761-3231 (map & directions on page 5; floorplan on page 6). Northwood's Kitchen Krew has planned a nice meal for us at lunch; check out the menu and other details on page 7 and ***please be sure to purchase your lunch ticket (\$9)*** when you register, before the meeting is called to order, or during the first break.

The full presbytery meeting packet starts with this letter. *Please print copies of the docket (found on page 3 immediately after this letter) and any other items you need to bring them to the meeting and/or download the full packet to a device on which you can view it at the meeting.* Northwood has open wi-fi but may not have the capability for too many of us to download the documents all at once.

Our worship service will include a special anthem, "Daughters of Promise, Women of Faith," commissioned by two members of the choir at Northwood Presbyterian Church. So that the rest of the Northwood church family could hear it, we've agreed to let Northwood livestream the service—which means anyone can "attend" the worship service at 9:15 a.m., too, by visiting Northwood's website at <http://northwoodpc.org/> and clicking on "Watch Livestream" on the menu at the top of the page. The order of worship is included on pages 10-13 in this packet; you can find more about the anthem in the music notes on page 13.

The Coordinating Team has designated our worship offering on May 4 to The Refugee & Migrant Women's Initiative (RAMWI), which seeks to empower, engage, and support refugee and migrant women in Tampa Bay as they navigate and settle in their new community. You can get a glimpse of RAMWI's work on pages 14-15. ***Checks for the offering should be made payable to "Presbytery of Tampa Bay."***

Our presbytery has the privilege of hearing from JyungIn (Jenny) Lee, 2018-2021 Moderator for Presbyterian Women in the PC(USA), Inc., in the morning plenary and will host a special networking/breakout group for members of Presbyterian Women and other members of the presbytery after lunch. You can read Jenny Lee's brief biography on page 16.

Registration for members, commissioners, and guests begins at 8:15 a.m. in Northwood's Family Life Center/Gym (you can find it on the floorplan on page 6), with refreshments there through the mid-morning mini-break. Organizational display tables will be set up in the breezeway connecting the gym to classrooms and the sanctuary on the north side of the building facing SR580---unless weather forces them inside! **The presbytery meeting begins promptly at 9:00 a.m. in the Sanctuary.**

First-time commissioners can participate in an online orientation to the presbytery meeting on Monday, April 29 at 7:30 p.m.; you can find more information on that at this link: www.presbyteryoftampabay.com/orientation, and see pp. 17-20 for additional help for first-time commissioners and guests.

Two other highlights planned for the meeting—in addition to the special anthem and guest speaker:

- The Commission on Preparation for Ministry will be introducing Becky Higman to the presbytery; Becky has just made the transition from Inquirer to Candidate.
- The Coordinating Team (CT) will recommend that the Presbytery call Rev. Libby Shannon as Emerging Ministries Associate (see p. 34 for the recommendation and page 35 for Libby's biographical statement).

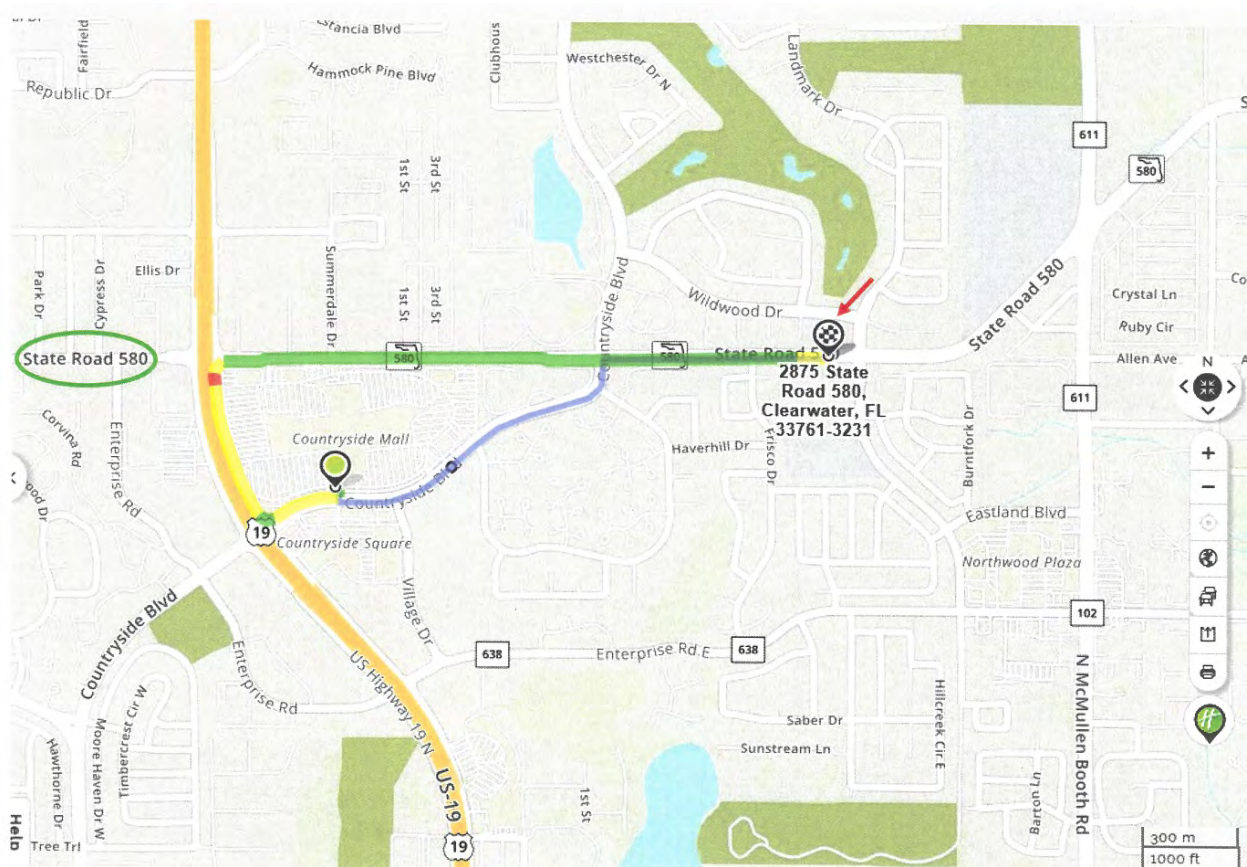

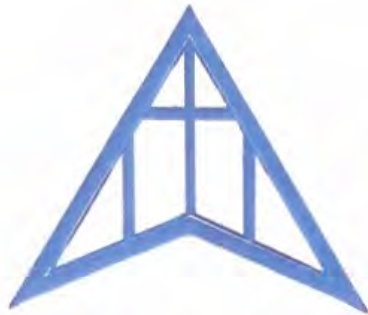

Northwood is located 1.2 miles East of U.S. Highway 19 at 2875 State Road 580, Clearwater.

State Road 580 is a divided highway in front of Northwood. It is not possible to turn left into Northwood when coming from the East via 580. Therefore, unless you are familiar with the area, it will be easiest for you to come via U.S. 19. At State Road 580, head toward Oldsmar {East} for 1.2 miles. You will pass Countryside Mall on your Right. You will pass through the light at Countryside Boulevard. The entrance to Northwood will be on your Right and BEFORE the light at Landmark Boulevard.

We are next door to Heritage United Methodist Church. Choose wisely! {If coming from a nearby neighborhood, there is an access road off of Landmark that cuts through the south part of Heritage's property to Northwood but it is not named. There is a small "Northwood Presbyterian Church" sign at the road.)

Last year, Northwood choir members Steve and Debbie Lang started the process to have Mr. Martin compose a musical piece in memory of their mothers, Rita M. Lang (1930-2017) and Lila G. Odom (1924-2003). Both women spent their lives actively participating in leadership roles in their respective churches in the Greenville SC area.*

Rita was among the first women Ruling Elders in the Presbyterian Church (U.S.A.) serving her local church and presbytery in multiple ways as well as serving nationally as a commissioner to the General Assembly.

Lila was an accomplished church musician serving as pianist and organist to Greenville churches for 60 years. She was an inspiration to thousands with whom she shared her gifts and also taught generations of students as a piano teacher.

Both were women of faith who lived their lives as an example of the love of Christ to their family and community. In “Daughters of Promise, Women of Faith” Joseph Martin has created a thoughtful text with uplifting music that fittingly honors these two women, but further summons us all to ‘answer the call’ and celebrate that ‘we’re one family of faith.’

As a member of the Human Relations Council in West Windsor, Jenny organized the first interfaith group in the town and led the group for four years. She received a Master of Divinity from Princeton Theological Seminary in 2015. Jenny was born in Seoul, Korea and has been living in NJ for over 40 years. Jenny has two grown sons who live in Manhattan and Washington DC. She enjoys having long brunch dates on weekends with her very supportive husband.

Hopefully Helpful Information for First-Time Commissioners and Guests to a Stated Meeting of the Presbytery of Tampa Bay

Presbytery Meeting Basics

As a Presbyterian, you probably already know the basics of our system of government, so let me share a few tips you may not realize:

- You are a Commissioner, not a Delegate
 - This means that no one, not your session, not your pastor, not your spouse, can tell you how to vote on a particular issue. That's between you and the Holy Spirit. As it says in the Foundations of Presbyterian Polity in the Book of Order, "Presbyters are not simply to reflect the will of the people, but rather to seek together to find and represent the will of Christ." (F-3.0204)
- You may not know who all these people are and what their jobs are, so here's a cheat sheet.

Cast of Characters:

- Moderator
 - Rev. Lori Ros Reiter, the person with the gavel. The Moderator is responsible to make sure the meeting runs well, and is the non-staff leader of the Presbytery.
- Vice Moderator
 - Elder Jonathan Owen also moderates part of each Presbytery meeting, and is the Moderator in waiting.
- Presbytery Coach and Coordinator
 - Elder Patrice Hatley is our Presbytery's coach and executive. She's the head of staff for the Presbytery of Tampa Bay and has a variety of responsibilities throughout the Presbytery.
- Stated Clerk
 - Rev. Bill Wildhack is the Presbytery's Acting Stated Clerk. As Stated Clerk he's responsible to help plan presbytery meetings, prepare the presbytery packet, and help the moderator keep the meeting running "decently and in order" as the Presbytery's parliamentarian. Bill is the "acting" stated clerk while the presbytery explores realigning some of the responsibilities our former stated clerk has as Director of Communications in addition to being the clerk.
- Treasurer
 - Elder Terry Dennis reports on how your giving to and through the presbytery is being handled. He's a volunteer officer of the Presbytery and responsible for the finances and budget of the Presbytery.

- You'll hear a lot of acronyms at a Presbytery meeting. Mostly these are refer to our Committees and Commissions. Some translations:
 - COM (Commission on Ministry)
 - The Commission on Ministry is the primary body responsible for making decisions about relationships between pastors and churches, whether a particular pastor may become a member of the Presbytery, etc. It does its work primarily in regions. The COM is chaired by Rev. Laurie Palmer. East Region Chair is Ruling Elder Kris Marone, Central Region Chairs are Revs. James Friesen and Susan Hill, West Region Chair is Ruling Elder Michael Clark.
 - CPM (Commission on Preparation for Ministry)
 - The Commission on Preparation is the primary body responsible for those seeking to become ministers, also known as Inquirers and Candidates. Chaired by Rev. Deb Belusa.
 - CCV (Commission on Church Vitality)
 - They have all kinds of resources and money to give to churches. The CCV is chaired by Rev. Micki Robinson.
 - NRC (Nominating and Representation Committee)
 - Responsible for nominating Teaching and Ruling Elders to most committees and commissions. Be sure to share your gifts and talents with new Chair Rev. Vicki ByRoade!
 - Trustees (Board of Trustees)
 - The Trustees are a Commission of the Presbytery that handles the legal side of Presbytery business, implementing decisions of the main body, but also approving requests from churches for things like leasing their sanctuary, selling property, etc. Chaired by Rev. Norm Hatter.
 - CT (Coordinating Team)
 - As the leadership group of the Presbytery, the Coordinating Team is a Commission made up of the chairs of each group above, as well as the Moderator and Vice-Moderator. The outgoing Moderator acts as the chair of the CT, while the Treasurer, Stated Clerk and Presbytery Coach and Coordinator all serve as ex officio members of the Team. Chaired by Rev. Libby Shannon.
- Presbytery meetings are guided by the most recent edition of *Robert's Rules of Order: Newly Revised*.
 - "No? Really?" you say. But yes, believe it or not, the Book of Order directs (G-3.0105) that Presbyterian councils (such as the Session or Presbytery or General Assembly) are governed by Robert's Rules of Order. That doesn't mean you have to be a parliamentary expert to attend meetings, but you should probably learn the basics below if you want the meeting to make sense once business begins.

Robert's Rules Quick Guide

Below is a summary of your rights and responsibilities under Robert's Rules. Generally speaking, these rules are intended to reduce tension, protect the rights and voice of the minority opinion, and of course, keep us doing things "decently and in order" (1 Cor. 14:40, ESV).

- Always address your comments to the Moderator (not "Madam Moderator or Mr. Moderator, just "moderator") or presenter, never to other commenters
- Generally, don't interrupt another speaker, but wait until you're recognized by the Moderator
 - EXCEPT for these reasons (not exhaustive):
 - You can't hear what's going on or you're so uncomfortable over the room temperature, etc. you can't stay in the meeting (say, "Point of Privilege" then explain the problem)
 - You think something was wrong with what just happened (say, "Point of Order" then state your objection. The moderator will then decide if you're right or not.)
 - You want to request information from the speaker (say, "Point of Information" and ask your question. This is NOT an opportunity to give information, but only to request it.)
- Some motions it may be useful to know about:
 - Call the Question, aka, Move the Previous Question
 - A request to vote on whether or not to vote. This motion requires a second, but isn't debatable. It can only be made after the Moderator recognizes you. Typically, it's made when someone thinks we've hit the limit of productive discussion, and we're running in circles. It is NOT appropriate to use this to shut down debate.
 - When you hear "Call the Question", be aware that the next vote is *not* on whatever it is we've been talking about, but on whether or not to continue discussion. An affirmative vote will end discussion, and the next vote is on the main motion.
 - To protect the rights of the minority opinion, this motion requires a 2/3 majority to pass.
 - Amendments to Main Motions
 - If you want to slightly modify the language of a motion, to add, delete or replace some language, you'll want to say "I move to amend the motion..." when the Moderator recognizes you. This requires a second, and will then be discussed and voted on.
 - Substitute Motions
 - If you want to substantially modify a motion on the floor, changing the intent or most of the language, you need to use a Substitute Motion instead of amending the current motion. When the Moderator recognizes you, you'll say "I move the following substitute motion" and read your alternative suggestion. You'll also want to provide a copy to the Stated Clerk in writing.

- Division of the House
 - If you think that a voice vote was too close to call, any member of the Presbytery may request a “Division of the House” or vote by raised hands or ballot.
- Order of the Day
 - Not a motion, but something you’ll see on the agenda, usually related to lunch. All “Order of the Day” means is that we need to drop whatever it is we’re doing when the time for that item arrives and start doing the “Order of the Day”.
- Not necessarily in Robert’s, but please follow these conventions of our Presbytery regardless:
 - **When you want to speak, please come to a microphone, and when recognized by the moderator state your name, status (clergy or elder) and church.**
 - **Please return your nametag lanyard and evaluation to Ann Marie at the end of the meeting.**
 - Please read the Presbytery Packet thoroughly *before* the meeting.
 - Especially, read the items on the “Consent Agenda” as those motions will be passed right at the beginning of the meeting unless you request an item to be pulled from the consent agenda for a separate vote.
 - You should also bring a copy of the Presbytery Packet with you—printed or digital—as there won’t be any additional printed packets at the meeting.
 - If you’re *really* into polity, you may also want to consult the Presbytery’s bylaws found on our website for more information about how our presbytery does business.

What makes the Presbytery of Tampa Bay different than other presbyteries?

Several years ago our presbytery underwent a transformation process which is only recently being brought to completion. This resulted in a new mission statement, some common values, and a more relational, “bottom up” model of doing its work.

Our Mission Statement—“to identify and strengthen leaders so that every congregation makes new and mature disciples for Jesus Christ”—helps us keep our focus on leadership development and outreach. Practically, this means that there is usually a component of training at Presbytery meetings, but also that there are intentional relational opportunities for us to get to know other leaders.

The core values we adopted during the transformation were to be ***relentlessly congregational, meaningfully connected, faithfully constitutional and unapologetically Christ-Centered***. We want to focus on helping our congregations succeed, our Teaching and Ruling Elders to know and lean on one another, our processes and meetings distinctively Presbyterian, while focusing not on ourselves but on our Leader, Christ.

Independent Auditors' Report

There is a growing reluctance to fund programs, ideas, and approaches that don't reflect a deep process of discernment.

Mission

CCV voted to release mission funding in the amount of \$20,000 for ongoing support of the feeding program begun by First Presbyterian Church, Port Richey which is being continued by Trinity Church of Seven Springs. (3.13.2019)

CCV voted to provide a \$500 gift to Villa International to support their scholarship fund.

CCV heard a report about the Refugee Assistance program and the work being done by Palma Ceia Presbyterian Church in conjunction with other agencies. The presbytery provided a grant of \$50,000 last year. Approximately \$38,000 has been used thus far.

Networks

Small Church:

23 people from the Presbytery attended the Small Church Conference in March. CCV funded a bus and provided scholarships for several attendees. The conference and the trip (21 on the bus) was well received with the suggestion that the presbytery fund a bus again – and the commitment from attendees to help fill the bus next year!

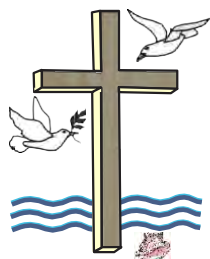

Motions for Presbytery

1. Approve calling Rev. Elizabeth “Libby” Shannon as Emerging Ministries Associate for a two-year term, which may be extended as determined by the presbytery, as described in the position description approved at the Stated Meeting of the Presbytery on February 21, 2019.

Actions Taken by the Committee

1. Approved designating the offering at the May 4, 2019 Stated Meeting of Presbytery to go to support refugee resettlement efforts through the Refugee and Migrant Women’s Initiative (RAMWI) in Riverview, FL.
2. Approved the docket for the May 4, 2019 Stated Meeting of Presbytery.
3. Approved terms of compensation for William A. Wildhack III to serve as Acting Stated Clerk half-time as of March 1, 2019, and forwarded Form F-1 to the West Region COM for final approval. Bill remains half-time as stated supply at First, Safety Harbor while serving as half-time acting stated clerk.
4. Advertised the Emerging Ministries Associate position in a special eNews distribution on Monday, March 18, with a cover letter from Patrice as point of contact for applications.

Items for Information

1. At the February 21, 2019, stated meeting, the Presbytery approved establishing the position of Emerging Ministries Associate and for the Coordinating Team, “a broadly representative body, which also serves as the Presbytery of Tampa Bay’s personnel committee” to recommend a candidate.
2. Libby Shannon, currently chair of the CT, was excused from the portion of the meeting before and after the CT interviewed her; Moderator Loli Reiter chaired these portions of the meeting. If the call is approved, final terms will be submitted on Form F-1 to the Commission on Ministry for review and action on May 9 so that Libby can start in the new position no later than June 1, 2019.
3. “Stated Clerk and Director of Communications” is a legacy title not reflected in either the By-laws or Manual of Operations, and CT is exploring realigning some of the functions David Baker performed in those two roles in new ways. Bill Wildhack has agreed to continue as part-time, acting clerk while those discussions continue and until a permanent clerk is elected by written ballot for a three-year term at a future stated meeting of the presbytery.

The Reverend Elizabeth (Libby) Shannon



Libby is a lifelong Presbyterian and a lifelong Floridian. She grew up in Bonita Springs and was baptized, confirmed, and ordained at The Moorings Presbyterian Church in Naples. During the summers of her youth, she spent more weeks as a camper at Cedarkirk, a participant in summer workcamp, and Montreat Youth Conference attendee than she spent at home. Libby attended Eckerd College where she studied abroad and worked as a counselor at Cedarkirk. Following seminary, Libby served in the capacity of an interim associate pastor for youth and then spent a year as a resident volunteer at the Stony Point Center in the Community of Living Traditions in Stony Point, New York. In August of 2010, she was called to as Associate Chaplain and Associate Director of the Center for Spiritual Life at Eckerd College. In 2016 she assumed the role of Director of the Office for Advocacy and Gender Justice in addition to her work as a chaplain.

Over the last nine years Libby has served the Presbytery of Tampa Bay on CPM; chaired the Administrative Commission for Westminster Presbyterian Church in St Petersburg; been a commissioner to the 222nd General Assembly; served as Vice-Moderator, Moderator, and chair of the Coordinating Team; has offered numerous presentations throughout the presbytery to PW groups, Sunday School classes, and mid-week gatherings; and enjoyed being a supply preacher to nearly every corner of the presbytery. **Coach and Coordinator
Report to the Presbytery
May 4, 2019**

In true Presbyterian fashion, the date for this particular meeting of the Presbytery was set way before my niece, Janika, set her wedding date....for the same day. So, as you meet at Northwood, I will be in Wiesbaden Germany celebrating her wedding to Christophe. It feels really weird to miss the meeting! Don't think I have missed a presbytery meeting in 10+ years. Anyway, I will be praying for you as you gather. This is a good opportunity to share some musings and learnings since we last met in February, most of that period of Lenten journey to Easter. It seems like most of my notable experiences have involved death and resurrection in some form. Maybe it's the same for some of you.

In mid-March I was able to make a pilgrimage with my learning cohort to Atlanta and then to Albany, Americus area. The journey began with an extraordinary time of conversation with Dr. Leanne Van Dyk, President of Columbia Theological Seminary, and a couple of professors. We talked a lot about preparation for ministry in the future church. We then made our way to the MLK Center in Atlanta, where we heard the Reverend Dr. King's recorded voice confronting societal norms and systems contributing to poverty and racism. We saw videos and photos of people who testified to the great risks Martin Luther King, Jr. took, even to the point of assassination.

As we drove to the Americus area, we passed by a small decrepit concrete building with a nearly unreadable old sign: Leesburg Stockade. Look it up. Horrifying that in 1963 over a dozen black girls ages 12-15 were arrested for trying to buy movie theater tickets in protest against the segregated movie theater. It seems they were sick of being called "pickaninny," too. They were taken 20 miles from home to the Leesburg Stockade and kept there for over two months. Their parents did not know where they were.

Another significant moment of this week away for me, was when I found myself having as my conversation partner at dinner at a private home in Americus, Linda Fuller Degelmann, widow of Millard Fuller. Linda is a formidable Christian justice advocate in her own right. She told so many stories of the profound risks she and Millard took in the early days of their work at Koinonia and then founding Habitat for Humanity. She even shared some of the very personal conflicts between themselves. Much of what I heard has not been published.

The strengths of Millard and MLK Jr were as prophets, I think. Maybe they were like John the Baptist, relentlessly pointing the way. They and others of their time shook the foundations of our society and our ministries by reminding us of Jesus' new commandment of selfless love. Over and over and over. MLK used his pulpit and even his jail cell to communicate very clearly what was at stake in our world. Fuller used hammers and nails to confront poverty by building houses everywhere, boldly recruiting a former President of the United States. My friend Wendy Tajima said it well, "they had an unbending sense of righteousness that got them in trouble."

Clearly they were larger than life, and they were also very human. Even Jesus had his moments of righteous anger, but his dominant message was one of forgiveness and grace extended not only to the most honorable but also the outcasts of society. Jesus was both a prophet of judgment and also a prophet of radical life-giving love and acceptance. His resurrection is proof of God's promise of hope. I think prophets of God come at exactly the right moment in time and I hope that we also can acknowledge that no one of us can be the right voice for all the people at all times. I give thanks for those who step forward in this relay to be the church and build the kingdom of heaven, continuing the mission with new or varied gifts and skills. Baton-passing is hard. One has to let go and one has to take hold. And you do this while you are both running full tilt. You might even feel like you're competing with each other rather than being on the same team.

There are many congregations in our presbytery at the point of baton-passing. And there are ministers that are also doing that same exchange. I invite you to consider how you, in your particular corner of the presbytery world, might serve as the prophetic witness to God's kingdom. By the way, don't read too much into that metaphor! Baton passing can mean things besides pastoral changes.

Would you also join me in praying for vitality of the many ministries we support?

Living God, we give you thanks and praise for the new things you are doing among us. For the transforming presence of Christ; for your call to follow the way of Jesus; for the gifts of your Word made flesh; for the good news of your holy realm; for Jesus' example of humble service; for your great love for all the world; for our common ministry in Jesus' name.

Living God, by the gifts of your Spirit, help us to bear witness to the risen Lord, proclaiming the good news of salvation; growing in the image of Christ; offering your grace to others; sharing the hope that is within us; loving and serving one another; extending your compassion to all; building up the body of Christ.

Living God, in the great mystery of our faith, receive us each night and revive us each day, that we may be dead to sin and alive to you; through Jesus Christ our Savior. Amen.

Financial report update as of March 31, 2019

The financial report for the first quarter of 2019 continues our recent upward trend in many different ways.

1. In unrestricted gifts to the Presbytery for mission work, we are \$3,500 ahead of last year with a budget that equals our 2018 actual.
2. Our Tampa Bay per capita is over last year comparative results by \$2,600 – but working against a budget that is \$30,000 lower than our 2018 results. So we have collected 31% of the budget in the first three months of the year, compared to only 27% of where we ended last year.
3. 26 of our congregations have made a payment towards per capita, with 5 of those already meeting 100% of their portion.

4. Our per capita expenses are thus far right on target for meeting our budget for the year.

I pray that this short note and the attached financial reports will answer any questions that you may have about the “numbers” side of the day to day great work done within our Presbytery. Our May meeting falls on the same day as graduation for Florida Southern College, so I will be busy participating in this important moment for our seniors and their families while you are together. 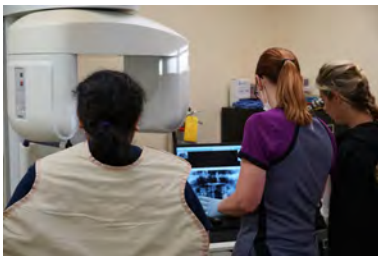

We greatly need volunteers in the following areas:

Tuesday Food Distribution	At present we are serving between 500 to 700 families a week through this pantry. Your church can help by holding a food drive of non-perishable canned goods. We also need volunteers to help distribute the food on Tuesdays, and package and prepare bags on other days during the week.
Step Up for Success	Mentors are needed to help students with basic life and job skills. These include helping students complete their required testing to earn a high school diploma, learn a trade, or prepare to enter the workplace.
Dental Clinic	The clinic is currently open two Saturdays a month. We need volunteer dentists, hygienists, and nurses to help support this ministry. Sovereign Immunity is offered to professionals once they complete an application with Beth-El and the Florida Department of Health.
Summer Youth Programs	Support Beth-El children and youth through a scholarship to Cedarkirk, Back to School Drive, leading a week of VBS or through a customized program designed by our staff and your mission team.
Outreach to Farms	This program takes resources directly to farmworkers who are unable to travel to the mission because of work or transportation issues. Volunteers are needed to help package and distribute these resources. A monthly meal is also prepared and served during the farming season.
Worship	Nuevo Camino at Beth-El leads worship services on Sunday mornings and Wednesday evenings. Volunteers are needed to help support their music ministry and Sunday school classes.

Hurricane Michael Update

April 2019

April 10th will mark the six-month anniversary of Hurricane Michael's landfall in the Florida panhandle. The type of destruction left by Michael has not been seen in Florida since Hurricane Andrew devastated Homestead in 1992. The Florida Presbyterian Disaster Assistance Network (FLAPDAN) has been working hard to support the response and recovery efforts within the Presbytery of Florida. Working closely with Florida Voluntary Organizations Active in Disaster (Florida VOAD), FLAPDAN has been instrumental in helping to match available resources with needs on the ground.



Volunteer response to Hurricane Michael has been strong, including many Presbyterian mission teams. Several groups have come to help clean up some of our churches and members' homes and many have put in countless hours helping to clear trails and repair structures at Dogwood Acres.

Presbyterian Disaster Assistance (PDA) has been walking alongside the presbytery since the storm hit, providing guidance, resources and grant funding to the presbytery and damaged churches. PDA is working with Volunteer Host Sites at Gulf Beach Presbyterian Church and Dogwood Acres and will also be supporting local communities with recovery grants.

Several Long-Term Recovery Groups (LTRGs) have formed in order to organize community resources, fundraise, recruit volunteers and facilitate repairs to homes for survivors that do not have the means to recover on their own. Disaster case managers work with clients to vet their needs, construction estimates are done on the damaged homes and volunteers do the needed repairs with materials that have been donated or purchased with donated funds.

Kathy Broyard, FLAPDAN's Executive Director and Emergency Management Specialist, has been working with the LTRGs to connect them to PDA and other resources. Kathy continues to make periodic trips to the panhandle from the FLAPDAN office in Gainesville to attend LTRG and other meetings and keeps presbytery and camp staff up to date. Through FLAPDAN's relationship with Volunteer Florida, we were able to secure a grant for \$25,000 for debris and tree
